The Investor Forum is pleased to announce joint winners of the Simon Fraser Stewardship Award for 2023 are Kimberley Lewis, Head of Active Ownership at Schroders and Helene Winch, Head of Responsible Investing at Premier Miton Investors.

The Award, presented at the Investor Forum's 8<sup>th</sup> Annual Review event on 23<sup>rd</sup> January, is named in honour of the founding Chair of the Investor Forum in recognition of his commitment to stewardship, his generosity of spirit and his ability to both recognise and bring out the best in the people around him.

## The winners

As Head of Active Ownership at Schroders, **Kimberley Lewis** is responsible for driving forward Schroders' stewardship strategy, encompassing engagement and proxy voting. Under Kimberley's leadership, the team has launched an Engagement Blueprint, setting out for companies, clients and other key stakeholders Schroders' Active Ownership priorities. The Investor Forum has welcomed Kimberley's continued commitment to making the case for effective stewardship, engagement and escalation, her valuable input as a member of the advisory group on the Best Practice dialogues project and as an expert speaker on our IFDP programme.

**Helene Winch** brings her wide experience of responsible investing to Premier Miton, where senior management value the impact she has made not just in the investment process but also in the wider business. She formed, and participates in, the Responsible Investing Oversight Committee, which provides oversight of the stewardship and responsible investing process to comply with the firm's responsibilities to various stakeholders. Over the year Helene has been responsible for developing the firm's net zero strategy and engaging with portfolio companies assessed as posing the highest climate risk. Helene is an active contributor to many Investor Forum projects, events and company engagements, and we value her insights.

# **Highly commended**

The judging panel also 'highly commended' **David Patt**, Responsible Investment VP at Columbia Threadneedle. In 2023, David was active in proposing UK companies for collective engagements, and made significant contributions to a number of Investor Forum Working Groups, including on Best Practice Dialogues and Proxy Voting provider feedback. His colleagues recognised the patience, tenacity and subject matter expertise that he demonstrates in his new role, and the Investor Forum team value the energy and insights he brings to all our conversations.
